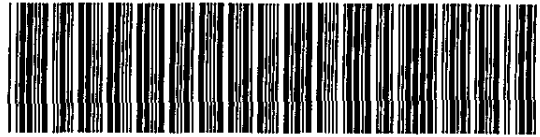

ARTICLES OF ORGANIZATION
OF
LAW OFFICES OF THERESA M. KIDD, P.L.

The undersigned does hereby make, subscribe, acknowledge and file the following articles for the purpose of becoming a Professional Limited Liability Company under the laws of the State of Florida.

ARTICLE I

The name of the Limited Liability Company shall be LAW OFFICES OF THERESA M. KIDD, P.L., and its principal office shall be located at 2820 U. S. Highway 1, South, Suite A, St. Augustine, St. Johns County, State of Florida, 32086; and the mailing address is the same. The Limited Liability Company shall have the ability to move the principal place of business and establish branch offices from time to time as the members may designate.

ARTICLE II

The general nature of the business to be transacted by the Limited Liability Company is:

(a) To engage in every phase and aspect of the business of rendering the same professional services to the public that an attorney at law, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees, and agents who are duly licensed under the laws of the State of Florida to practice law therein.

(b) To invest the funds of the Limited Liability Company in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real and

personal property necessary for the rendering of professional legal services.

(c) To do everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Organization or any amendment thereto, necessary or incidental to the protection and benefit of the *Limited Liability Company*, and in general, either alone or in association with other corporations, firms, or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects of the *Limited Liability Company*.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of the *Limited Liability Company*; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the *Limited Liability Company* otherwise permitted by law.

ARTICLE III

The period of duration for the *Limited Liability Company* shall be perpetual.

ARTICLE IV

The *Limited Liability Company* is to be managed by a manager or managers, as may be set forth in the Operating Agreement. Until otherwise provided in the Operating Agreement, the name and address of the initial Manager(s) shall be:

ARTICLE V

The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be set forth in the Operating Agreement.
