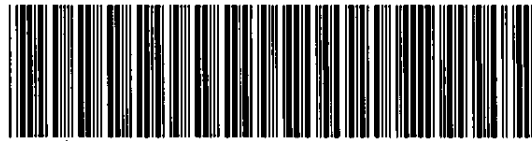

TAMIAMI INTERNATIONAL ORCHID FESTIVAL, LLC

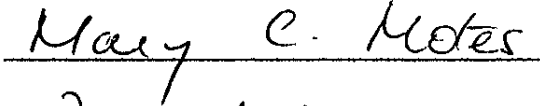
2. In all other respects the articles of the Limited Liability Company shall remain as originally filed with the Division of Corporations.

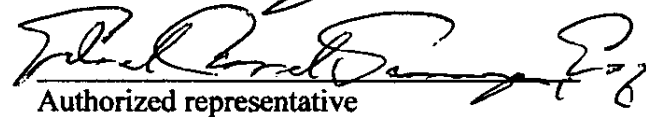

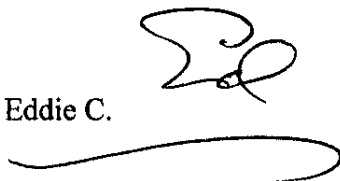
