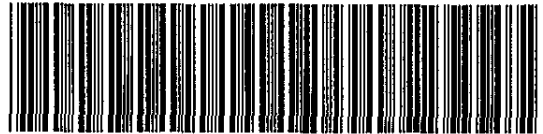

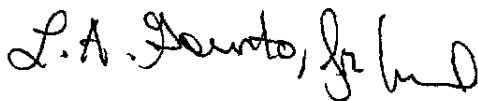

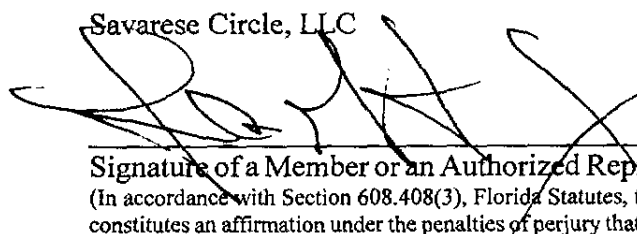

NAME

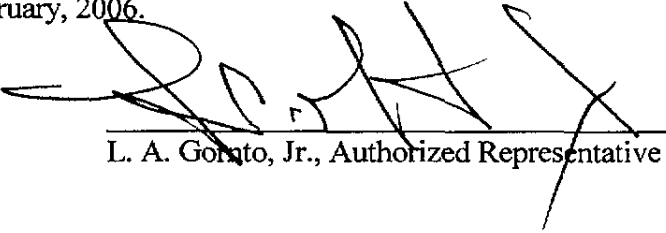

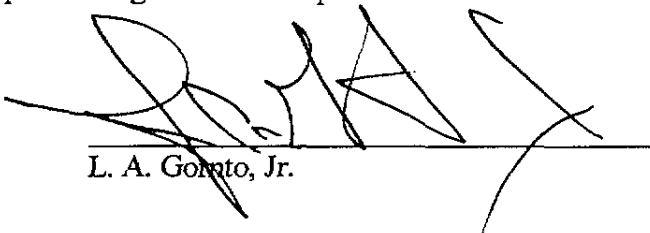
