ARTICLES OF ORGANIZATION OF BUCK BYWAY PROPERTIES, LLC

The undersigned, being a duly authorized representative of the Members, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608. Florida Statutes, does hereby adopt the following Articles of Organization and hereby certifies that:

ARTICLE I - NAME

The name of the limited liability company is BUCK BYWAY PROPERTIES, LLC (hereinafter referred to as the "Limited Liability Company").

ARTICLE IV - PURPOSE

The purpose for which the Limited Liability Company is being formed is to engage in any activity or business permitted under the laws of the United States and State of Florida.

ARTICLE VI - ADDITIONAL MEMBERS

Additional Members of the Limited Liability Company may be admitted upon the approval of all of the Members of the Limited Liability Company and otherwise in the manner set forth in the Regulations of the Company.

ARTICLE VII - MANAGEMENT

Such Managers shall also have the rights and responsibilities described in the Regulations of the Limited Liability Company. Until the first such election of the Members, the Limited Liability Company shall be initially conducted, carried on and managed by one (1) Manager, and the name and address of the initial Manager is as follows:

Such Manager shall serve in such capacity until the first annual meeting of the Members or until his successor is duly elected and qualified.

ARTICLE VIII - REGULATIONS

The power to adopt, after, amend or repeal the Regulations of the Limited Liability Company shall be initially vested in the Members of the Limited Liability Company and thereafter in the manner prescribed by and provided in any adopted Regulations of the Limited Liability Company.

ARTICLE IX - LIMITATION ON AGENCY AUTHORITY OF MEMBERS

Pursuant to section 608.424 of the Florida Limited Liability Company Act, no Member of the Limited Liability Company solely by virtue of being a Member, and no Member shall have authority to incur debt or contractual liability on behalf of the Limited Liability Company solely by virtue of being a Member.
