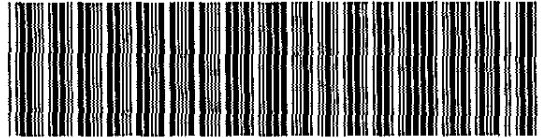



ARTICLE I
Name of Company

Bob Mathews Inspection Services LLC

ARTICLE II
Business of Organization

The limited liability company may engage in the business of new and existing home inspections, commercial building inspection, and expert witness services, and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III
Principal Place of Business

The principal place of business of the limited liability company shall be: 2620 Halperns Way, Middleburg, FL 32068, and the mailing address shall be the same.

ARTICLE IV
Duration

The existence of this limited liability company shall commence upon the filing of these Articles of Organization with the Florida Department of State, and thereafter it shall have perpetual existence.

ARTICLE V
Member-Managed Company

Its members shall manage the limited liability company. The names and address of the

initial members are: Robert L. Mathews and Joyce M. Mathews, husband and wife, 2620 Halperns Way, Middleburg, FL 32068, who shall own their interest in the company by the entireties, as husband and wife which shall include the right of survivorship. The members shall manage the limited liability company by majority-in-interest of the members as defined under Section 608.402 (17), Florida Statutes, unless otherwise provided in the Operating Agreement.

ARTICLE VI

Organization, Control and Structure of Company

The organization, control and structure of the limited liability company, other than specified herein, shall be governed and controlled by the Operating Agreement, if any, entered by the initial members, as may be amended from time to time by the then existing members as set forth in said Operating Agreement.

ARTICLE VII

Registered Agent

ARTICLE VIII

Indemnification

The limited liability company shall indemnify its members and agents to the fullest extent permitted by law.

Compensation

The members shall have the power to set the amount, if any, of the compensation to be

paid to the member(s) of the limited liability company.

ARTICLE X
Members' Right To Continue Business

Unless otherwise provided in the Operating Agreement, the death of a member shall not be an event causing termination of the limited liability company; provided that there is more than one member at that time. Unless otherwise provided in the Operating Agreement, the filing for bankruptcy by a member shall terminate the bankrupt member's interest in the limited liability company. The member(s), if any, remaining after the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or any other event which terminates the membership of a member, have the right to continue the business of this limited liability company subject to approval by the unanimous vote of the remaining member(s); provided that there is at least one remaining member.


