ARTICLE I Name of Company

Bob Mathews Inspection Services LLC

ARTICLE II Business of Organization

The limited liability company may engage in the business of new and existing home inspections, commercial building inspection, and expert witness services, and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.
