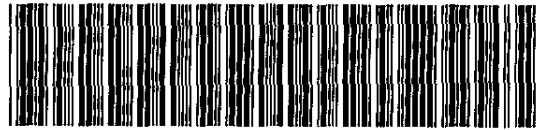

MANAGEMENT AND POWERS**


