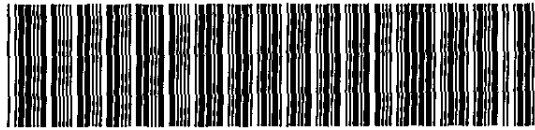

c. ARTICLE IV, Management of Business, is amended to read as follows: The Company shall be member managed. The name and address of the managing member is:

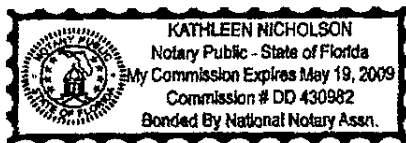

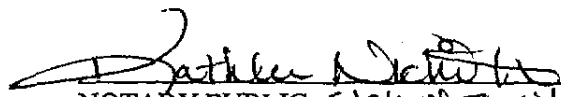

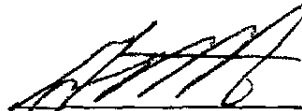
