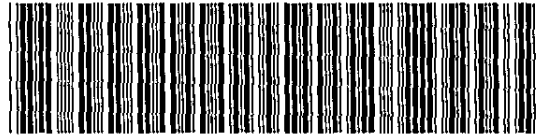

Additional members may be admitted and the terms and conditions of the admissions shall be that each member consents in writing to the admission of the additional member.


ARTICLE VI


