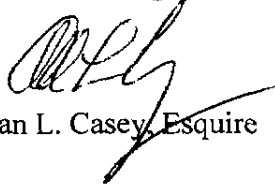

ARTICLE VII – Duration

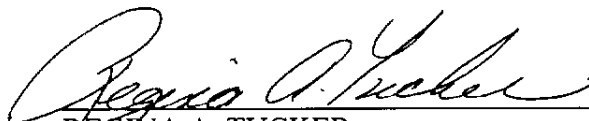
This limited liability company shall exist until dissolved in a manner provided by law, or as provided in the Operating Agreement of the Company.

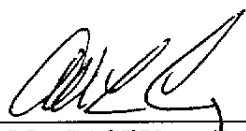
