FIRST: The name of the limited liability company is Ports America Tampa, LLC (the "Company").

- (b) amend the Articles of Organization; or
- (c) dissolve, liquidate, consolidate, merge, or sell all or substantially all of the Company's assets.
- 2. The Independent Director is to consider the interests of the Company's creditors in connection with all company actions.
