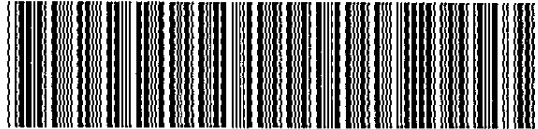

The name of the Limited Liability Company is PIRATES MUTINY, LLC (the "Company").


