#### ARTICLES OF ORGANIZATION

OF

### NORRIE GATEWAY, LLC

THE POS PAINT The undersigned, being a duly authorized representative of a Member, desiting to form \$100.000. limited liability company under and pursuant to the Florida Limited Liability Company Act, chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization and hereby certifies?

### ARTICLE I: NAME

#### <u>ARTICLE Y: REGISTERED AGENT AND OFFICE</u>
