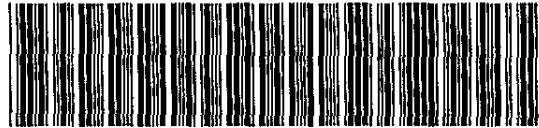



**ARTICLES OF AMENDMENT
To The Articles of Organization
Of

are disqualified by reason of legal minority. Nothing in this Amendment shall bar appointment as a Member of any person upon attainment of legal majority.


BE IT KNOWN, the remainder of the provisions of the articles of organization shall remain as filed on February 23, 2006.
