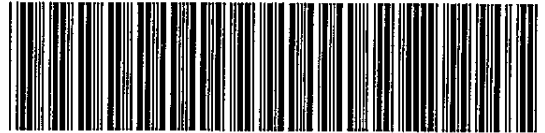


FIRST: The Articles of Organization were filed on 02/09/06 and assigned document number 100000020127.
