**ARTICLES OF ORGANIZATION FOR  
FLORIDA LIMITED LIABILITY COMPANY**

**ARTICLE I - Name**

The name of the limited liability company is MKN, LLC.

**ARTICLE II - Address**

The period of duration of the limited liability company shall be perpetual.

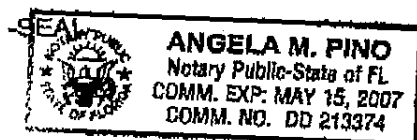
