The Company shall be deemed to have commenced its existence on the date of the filing of these Articles of Organization with the State of Florida.





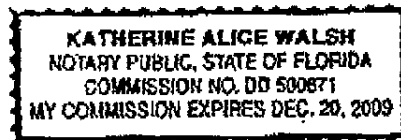
