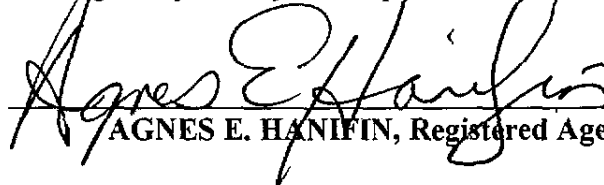

Article VI

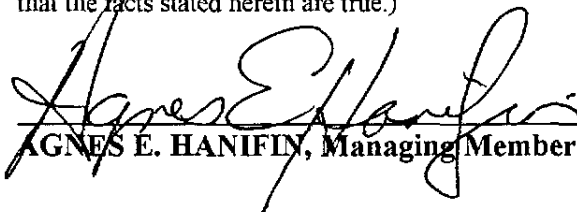
