**ARTICLES OF ORGANIZATION OF WILLIAM FINCH HOUSE SERVICES, L.L.C.
LIMITED LIABILITY COMPANY**

The undersigned, being authorized to execute and file these Articles, for the purpose of forming a limited liability company, under the Florida Limited Liability Company Act, F.S. Chapter 608, as amended, hereby makes, acknowledges and files the following Articles of Organization:

ARTICLE I Name

The name of the limited liability company is: WILLIAM FINCH HOUSE SERVICES, L.L.C.

ARTICLE II Address

The right, if given, of the Members to admit additional Members and the terms and conditions of the admissions shall be: duly qualified additional Members may be admitted on the unanimous written approval of all Members of the Company on such terms and conditions as shall be determined by all the Members; provided that such proposed new Member shall execute a counterpart of the Regulations and agree to bound by all provisions thereof and execute any other documents that the Company may deem necessary or appropriate.

ARTICLE VIII Members Rights to Continue Business

The right, if given, of the remaining Members of the limited liability company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the limited liability company shall be as follows: the Company shall continue upon the withdrawal of a Member by reason of death, retirement, resignation, expulsion, bankruptcy or dissolution.
