**ARTICLES OF ORGANIZATION FOR FLORIDA  
PROFESSIONAL LIMITED LIABILITY COMPANY**

The undersigned authorized representative, desiring to form a professional limited liability company pursuant to the provisions of the Professional Service Corporation and Limited Liability Company Act, hereby submits these Articles of Organization.

**ARTICLE I - Name**

The name of the professional limited liability company shall be: Integrative Wellness Center, P.L.

**ARTICLE II - Address**

**ARTICLE III - Effective Date**

The professional limited liability company shall commence to exist on March 1, 2006.

**ARTICLE IV - Nature of Business**

The general nature of business to be transacted by the professional limited liability company, or the objects or purposes of the professional limited liability company, shall be as follows:

- (a) To engage solely and specifically in the practice of oriental medicine.

**ARTICLE V - Management**

The professional limited liability company shall be managed by one or more managers in accordance with the operating agreement for said company.

**ARTICLE VI - Membership Units**

The total number of membership units authorized to be issued by the professional limited liability company shall be 10,000 units, par value \$.01. Each of the said units shall entitle the holder thereof to one (1) vote at any meeting of the members. All or any part of said units may be paid for in cash, in property, or in labor or services at a fair valuation to be fixed by the managers of the professional limited liability company at a meeting called for such purposes. All membership units then issued shall be paid for and shall be nonassessable. The professional limited liability company elects to have preemptive rights.

**ARTICLE VII - Ownership**

The initial member, namely Gary M. Rippa, shall be the sole owner of the professional limited liability company, unless one or more additional members are admitted.

**ARTICLE VIII - Admission of Additional Members**

Additional members may be admitted pursuant to the consent of the initial member. However, no individual may be admitted as a member unless such individual is duly licensed and otherwise legally authorized to practice oriental medicine, and no entity may be admitted as a member unless such entity is a professional service corporation or a professional limited liability company that is duly licensed or otherwise legally authorized to practice oriental medicine.

**ARTICLE IX - Right of Members to Continue Business**

The remaining member or members of the professional limited liability company, if any, shall be entitled to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the professional limited liability company.
