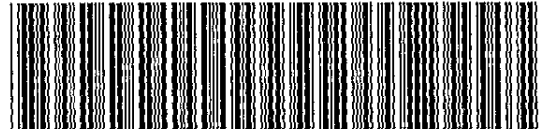

ARTICLES OF ORGANIZATION  
OF  
JAH ARCHITECTS, LLC

The undersigned, desiring to form a limited liability company under the provisions of Sections 605.401 et seq., Florida Limited Liability Company Act, as amended, hereby sets forth the following:

Article I. Name. The name of the Limited Liability Company is JAH ARCHITECTS, LLC

Article II. Principal Office. The mailing address and the street address of the principal office of the Limited Liability Company is 6306 Nikki Lane, Tampa, Florida 33625.

Article III. Registered Office and Agent. 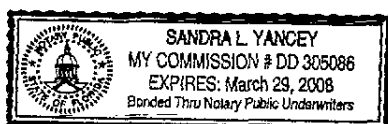




