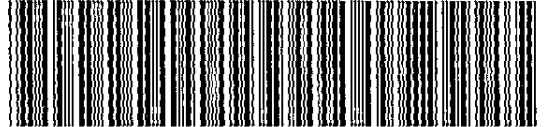


**ARTICLE V           INITIAL REGISTERED AGENT**


