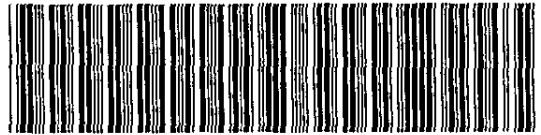

NAME**
