TO
ARTICLES OF ORGANIZATION
FOR
TELADVOCATE COMMUNICATIONS, LLC

The undersigned, desiring to amend the Articles of Organization for TELADVOCATE COMMUNICATIONS, LLC, a Florida limited liability company, under and pursuant to Chapter 605, Florida Statutes, does hereby adopt the following Articles of Amendment to the Articles of Organization for such company:

1. The Articles of Organization for TELADVOCATE COMMUNICATIONS, LLC were filed on February 28, 2006 and assigned document number L06000021369.
2. The following amendment to the Articles of Organization was adopted by the limited liability company: Article V is hereby deleted in its entirety and replaced with the following:

ARTICLE V. MANAGEMENT

This Company shall be a manager-managed limited liability company. The managers shall be Michael Boland and Tyler Haulk with an address of 8675 Hidden River Parkway, #180, Tampa, FL 33637.

3. The following amendment to the Articles of Organization was adopted by the limited liability company: A new Article VII is hereby added, as follows:

ARTICLE VII. INDEMNIFICATION

This Company shall indemnify any member, manager, officer, director, employee, or agent, and any former member, manager, officer, director, employee, or agent, to the full extent permitted by law.

4. All other terms and provisions of the Articles of Organization that were filed with the Secretary of State under document number L06000021369 shall remain unchanged.

These Articles of Amendment to the Articles of Organization are executed this 31st day of August, 2019 and are effective upon filing with the Secretary of State of the State of Florida.
