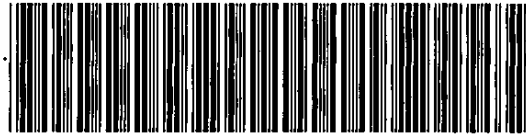

THE UNDERSIGNED, as duly authorized member-managers of DEEBEE, L.L.C., hereby give notice of the following Resolution wherein Articles of Dissolution were adopted.

At a meeting of all the members and all of the member-managers of DEEBEE, L.L.C., it was determined to file Articles of Dissolution with the Secretary of State of the State of Florida.


1. Description of the occurrence or occurrences that resulted in the company's dissolution: The company has ceased all business operations of any kind, nature and description. Further, it has been determined that another limited liability company with the same name was previously authorized to conduct business in the State of Florida, and thus the members of this company decided it was in the best interest of this company as well as in the best interest of the other company with the same name, if this company were dissolved immediately or as soon as permitted by the laws of the State of Florida. This Resolution refers solely to that certain DEEBEE, L.L.C. that is Document Number L06000021602 and which was filed February 24, 2006, and had an effective date of February 20, 2006.
2. All of the debts, obligations and liabilities of the company have been paid or discharged. In fact, the company owned no property, had no employees for which any obligations were due, incurred and therefore had no debts and no creditors.
3. All remaining property and assets have been dissolved, or in the alternative, in fact, the company never had any assets or property to be distributed to its members.
