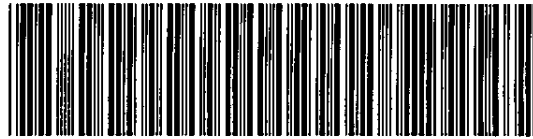

**FIRST:** The Articles of Organization were filed on March 23<sup>rd</sup>, 2006 and assigned document number L06000021882


