ARTICLES OF ORGANIZATION OF

ARTICLE I

NAME

The name of this Limited Liability Company shall be JAV MANAGEMENT LLC. (the "Company").

DURATION

ARTICLE VII
NEW MEMBERS

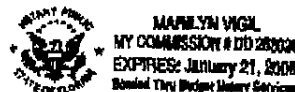


