Address

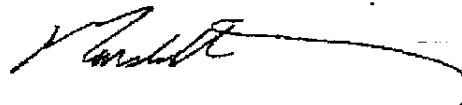

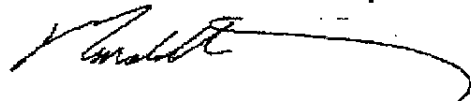
