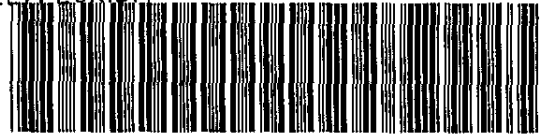



Article I. - Name

The name of the limited liability company is "Escuderia Group LLC" (the "Company").

Article II. - Address

Article VII. – Members' Right to Continue Business






