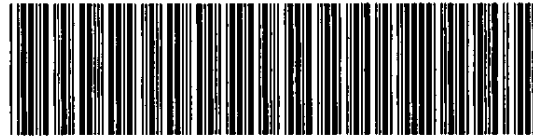




1. **Change of Mailing Address.** The mailing address of the company is hereby changed to 5158 Sea Chase Drive, #5, Amelia Island, FL 32034.


