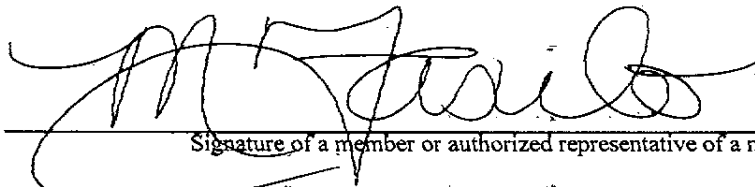
FIRST: The Articles of Organization were filed on March 1, 2006 and assigned document number L06000022517.
