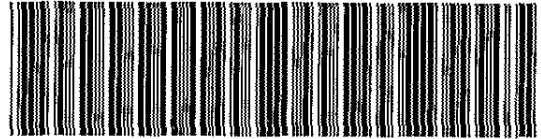

**ARTICLES OF ORGANIZATION**

**OF**

**WINDWARDS MOTION GRAPHICS AND VIDEO, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be WINDWARDS MOTION GRAPHICS AND VIDEO, LLC ("Company").

**ARTICLE II -- ADDRESS**
