ARTICLES OF ORGANIZATION OF RS INVESTMENTS GROUP, LLC

- 1. Name. The name of this limited liability company is RS INVESTMENTS GROUP, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
