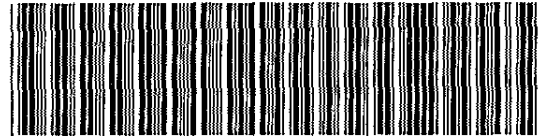

The undersigned Member has made and subscribed these Articles of Organization this 2nd day of March, 2006.


