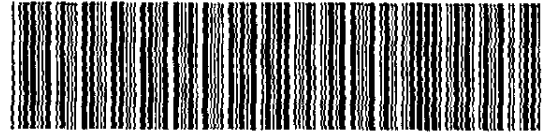

ARTICLE IV – MANAGEMENT




