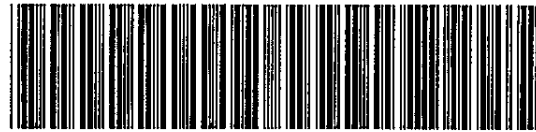

**ARTICLES OF ORGANIZATION  
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (the Florida Act), hereby adopt and file the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be:
