ARTICLES OF ORGANIZATION**OF****MISSION REAL ESTATE DEVELOPMENT GROUP, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Mission Real Estate Development Group, LLC (the "Company").

ARTICLE V - MANAGEMENT


