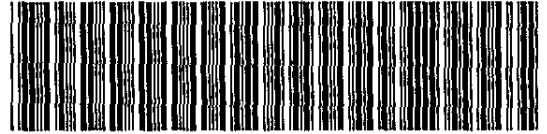

**ARTICLES OF ORGANIZATION  
FOR  
OMNITAX LLC**

Pursuant to Chapter 608, Florida Statutes, the articles of organization are as follows:

**ARTICLE I**

**NAME OF LIMITED LIABILITY COMPANY**

- 1.01 NAME. -- The name of this limited liability company shall be OMNITAX LLC.

**ARTICLE II**

**GENERAL NATURE OF BUSINESS**

- 2.01 POWERS. -- This limited liability company is organized for the purpose of transacting any and may engage in any activity and all lawful business permitted under F.S. 608 of the laws of the State of Florida and the laws of the United States of America.
