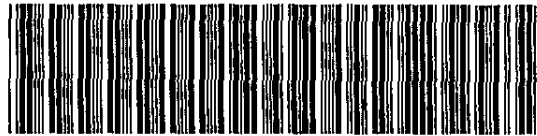

**ARTICLES OF ORGANIZATION
FOR

Pursuant to Chapter 608, Florida Statutes, the articles of organization are as follows:

**ARTICLE I
NAME OF LIMITED LIABILITY COMPANY**

1.01 NAME. -- The name of this limited liability company shall be SANDY SHORES PROPERTIES LLC.




