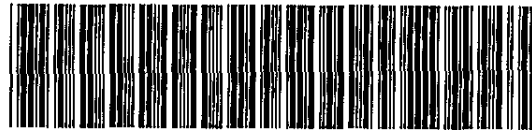

The name of the Limited Liability Company is PRO TURF SPECIALISTS, LLC.




