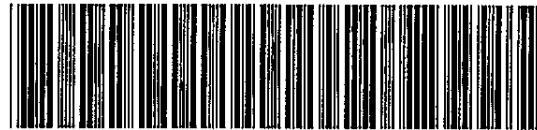

ARTICLES OF ORGANIZATION  
OF  
PRADO PLACE, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I  
NAME AND PRINCIPAL OFFICE

The name of the Limited Liability Company shall be PRADO PLACE, LLC ("Company"). The mailing address and principal office of the Company is: 2804 Del Prado Boulevard South, Suite 107, Cape Coral, Florida 33904.

ARTICLE II  
DURATION

The Company shall commence its existence upon the filing of these Articles of Organization, and its existence shall be perpetual unless the Company is dissolved as provided in these Articles of Organization.

ARTICLE III  
PURPOSES AND POWERS

The general purpose for which the Company is organized is to acquire, own, hold, lease, develop, encumber and convey real estate, and to conduct other activities incident to same. The Company shall also be authorized to transact any lawful business for which a Limited Liability Company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a Limited Liability Company under the laws of the State of Florida.

Such Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with the law or these Articles of Organization.

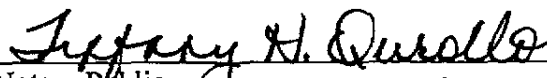

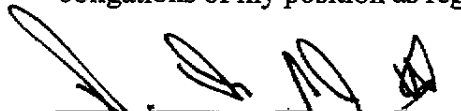
