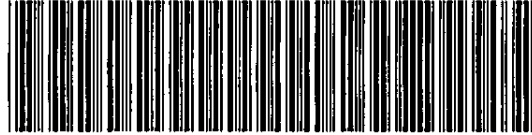


The name of our company be changed to Tampa Bay Home Stagers, LLC.
