The management of the Company shall be vested in the managers of the Company, as appointed by the members.

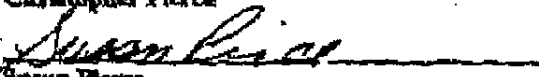
**ARTICLE VIII**
