PLAN OF MERGER OF KN NEWCO, LLC, WITH AND INTO DKN HOLDINGS, LLC

DKN Holdings, LLC, a Florida manager-managed limited liability company, and KN Newco, LLC, a Florida manager-managed limited liability company, hereby adopt and approve the following plan as the Plan of Merger required by Section 608.438, Florida Statutes. The terms of the plan are as follows:

- The names of the business entities planning to merge are DKN Holdings, LLC, a Florida manager-managed limited liability company ("DKN"), and KN Newco, LLC, a Florida manager-managed limited liability company ("Newco"). As a result of the merger, Newco shall be merged with and into DKN. DKN shall be the surviving business entity.
- The merger shall be effective on the date the Articles of Merger are filed with the Department of State (the "Effective Date").
- As a result of the merger, the membership interest of the member of Newco shall be cancelled. The membership interest of DKN shall be converted into a . multi-member membership interest by the former member of Newco and the pre-existing sole member of DKN.
