ARTICLE II

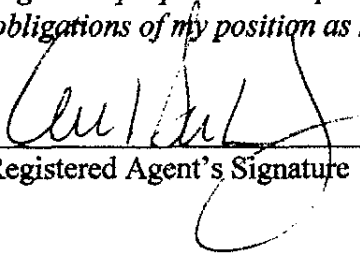
