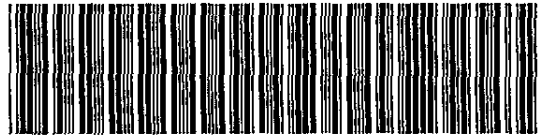

ARTICLE II

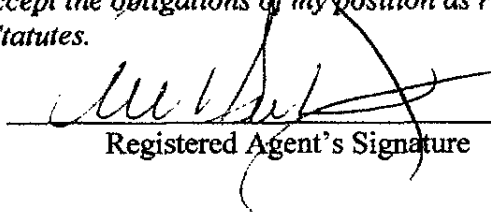
