ARTICLES OF ORGANIZATION

KNOW ALL MEN AS THESE PRESENTS:

That the undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608.407, hereby makes, acknowledges, and files the following Articles of Organization.

I DO HEREBY CERTIFY:

ARTICLE I

NAME. The name of the limited liability company shall be:

REGISTERED AGENT. The registered agent of the company and the street address of the Company's initial registered office in the State of Florida shall be:

CAPITAL CONTRIBUTION. The members of the company shall contribute to the capital of the company the cash or property set forth in Exhibit "A".

ADDITIONAL CAPITAL CONTRIBUTIONS. Each member shall make capital contributions to the company only upon the unanimous consent of all the members.

ARTICLE VII

ADMISSION OF NEW MEMBERS. No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms as shall be determined by all the members. A member may transfer his or her interest in the company only as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all other existing members of the company, other than the member proposing to dispose of his or her interest, approve of the proposed transfer by unanimous written consent.

ARTICLE VIII

TERMINATION OF EXISTENCE. The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by the consent of all the remaining members, provided there is at least one remaining member.

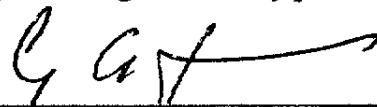
