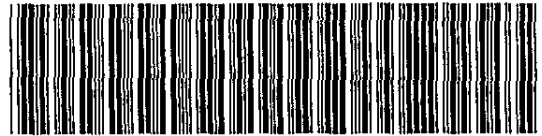



ARTICLES OF ORGANIZATION
OF
NW 44TH COMPLEX, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge and file these Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company shall be NW 44TH COMPLEX, LLC ("Company").

ARTICLE II - ADDRESS

The mailing address of the principal office shall be Post Office Box 2463, Ocala, Florida, 34478.

ARTICLE III - EFFECTIVE DATE AND DURATION

ARTICLE VII - MANAGEMENT


