ARTICLES OF ORGANIZATION  
OF  
MOBILE FRESHNESS TRADING, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608)

1. Name. The name of this limited liability company is Mobile Freshness Trading, LLC ("Company").

2. Duration. The Company shall have existence until December 31, 2030.

3. Mailing Address and Street Address. The Company's mailing address is 14703 Park of Commerce Blvd, Jupiter, Florida 33478. The Company's street address is 14703 Park of Commerce Blvd, Jupiter, Florida 33478.

7. Management of the Company. The Company shall initially be managed by the following person who shall serve as manager until the first annual meeting of the members or until his successor is elected and qualifies:


