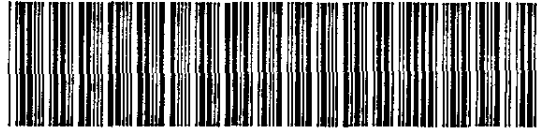

The undersigned hereby forms a limited liability company under the laws of the State of Florida.

ARTICLE I NAME

ARTICLE III COMMENCEMENT OF EXISTENCE

ARTICLE V INITIAL REGISTERED AGENT

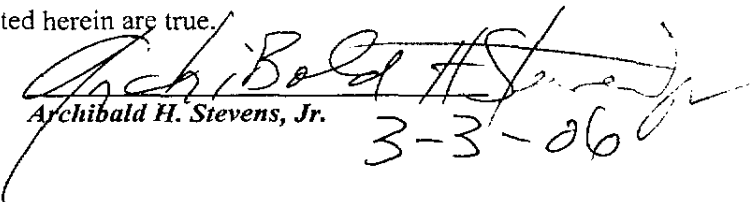

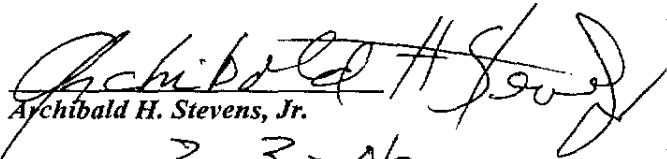
